| <b>Qualification Title</b>            | L3 Emergency Paediatric First Aid   |
| <b>Course Duration</b>                | 1 Day   |
|                                       | A minimum of 6 hours in the classroom, consisting of practical and theoretical activities. The sessions can be spread over a maximum of 3 weeks should this better suit the needs of your business. Each session must be at least two hours long.   |
| <b>Certificate Validity</b>           | 3 years   |
| <b>Max No of delegates</b>            | 12  |
| <b>Description</b>                    | <p>A level 3 First Aid course designed for those who have an interest in child and baby Basic Life Support but not necessarily governed by the Early Years Foundation Stage (EYFS) or OFSTED. The course covers life threatening conditions and includes CPR, bleeding control and choking.</p> <p>On successful completion of the course the learner will have gained the skills required to deal with a range of Paediatric First Aid situations.</p> <p>This qualification is unit 1 of the 2-day Paediatric First Aid qualification. From gaining this Emergency Paediatric First Aid qualification learners could progress to completing unit 2 and being awarded the 2-day Award in Paediatric First Aid.</p> |
| <b>Who should attend?</b>             | Students must be a minimum of 16 years of age.  |
| <b>Syllabus</b>                       | A range of subjects are covered including role of the Paediatric First Aider, primary survey, resuscitation (CPR including the safe use of an AED), wounds, bleeding and shock, seizure, choking, minor injuries, recovery position.  |
| <b>Assessment &amp; Certification</b> | <p>The qualification is assessed both through practical demonstration and written assessment.</p> <p>A learner must successfully pass both the written and practical assessments to achieve the qualification. There is no grading of the assessment.</p> <p>The qualification is valid for three years from the date of achievement. At the end of this period the learner will need to complete the full course again to requalify for another three years.</p>   |
| <b>Refresher Training Recommended</b> | Annual refresher training is strongly recommended.  |
